Title: Analyzing Fatal Fires to Understand Victim Behavior

Course Summary: This course provides an overview of human behavior and decision-making during fire incidents, and the factors that influence them. Students will be introduced to a systematic approach to investigating fatal fires and examining the behaviors and decisions of fire victims. Emphasis will be placed on collecting information from the fire scene, witnesses, known associates, health care providers, and the forensic pathologist to determine the actions of victims prior to becoming incapacitated by products of combustion.

Bio: Paul Ayres is a Sergeant in the Investigations Division of the State Fire Marshal's Office of Texas. Throughout his career, he has investigated over 270 fire/explosion incidents, including 20 fatal incidents with a total of 32 fatalities. Before working for the State Fire Marshal's Office, Paul held positions with Dallas Fire-Rescue Department, Rockwall Fire Department, and Williamson County Fire Marshal's Office. In addition to advanced-level TCFP and TCOLE certifications, he is certified as an IAAI-CFI, NAFI-CFEI, NAFI-CVFI, and Certified Fraud Examiner (CFE). Paul holds an associate's degree in Fire Science, a bachelor's degree in Emergency Management, a graduate certificate in Homeland Security, and a master's degree in Public Administration. He is currently enrolled as a doctoral student studying Forensic Science (Arson & Explosives) at Oklahoma State University. Paul instructs fire science courses at Trinity Valley Community College and serves as the Department Chair of the Fire Science Program.
